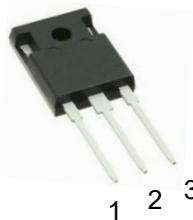

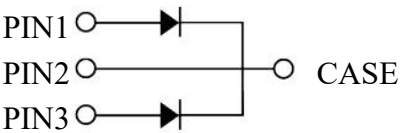

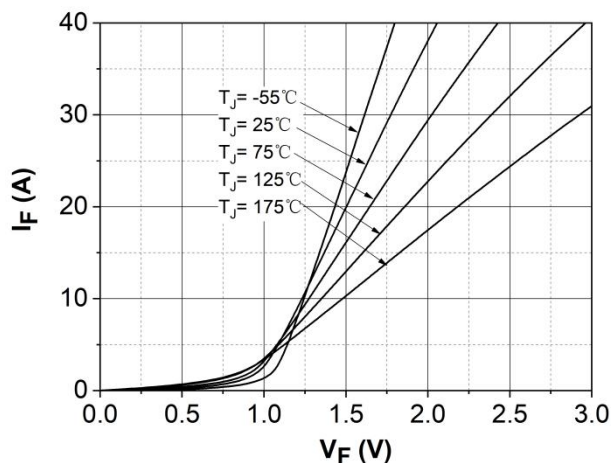


Figure 1. Forward Characteristics

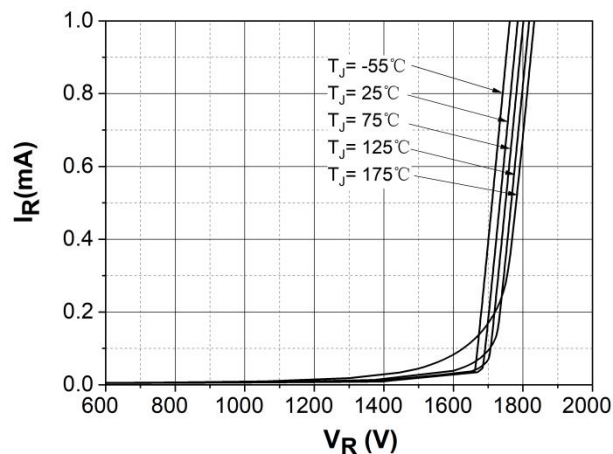


Figure 2. Reverse Characteristics

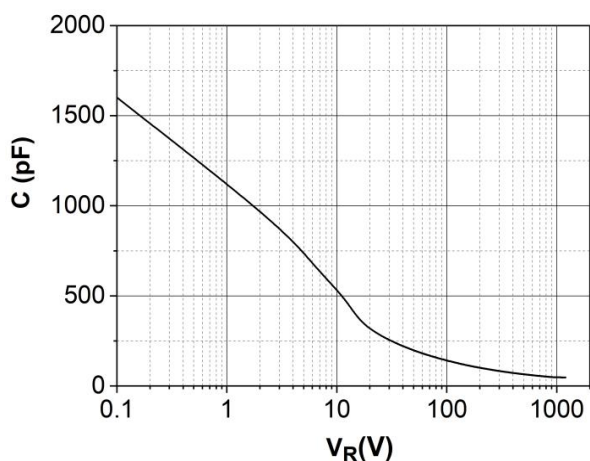


Figure 3. Capacitance vs. Reverse Voltage

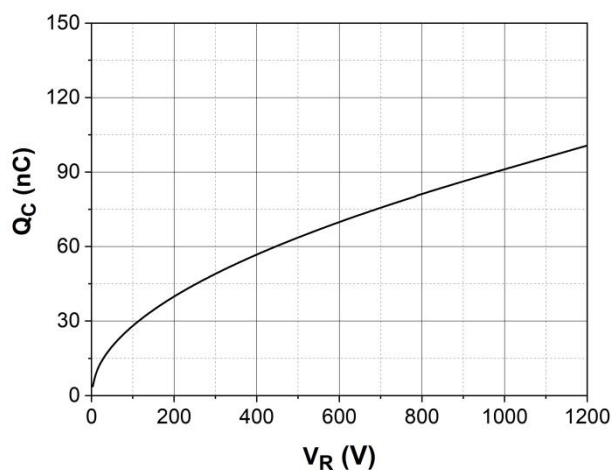


Figure 4. Recovery Charge vs. Reverse Voltage

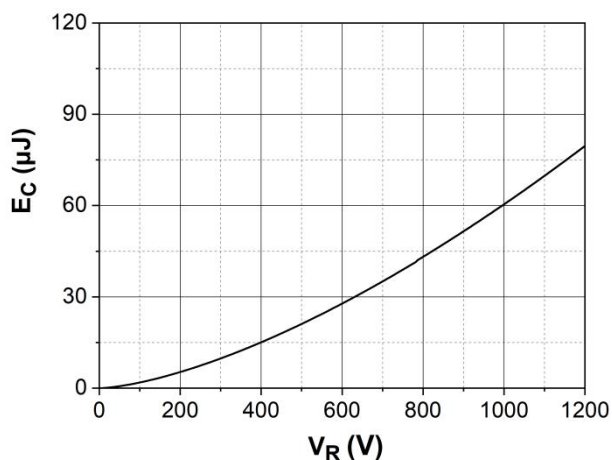


Figure 5. Typical Capacitance Stored Energy

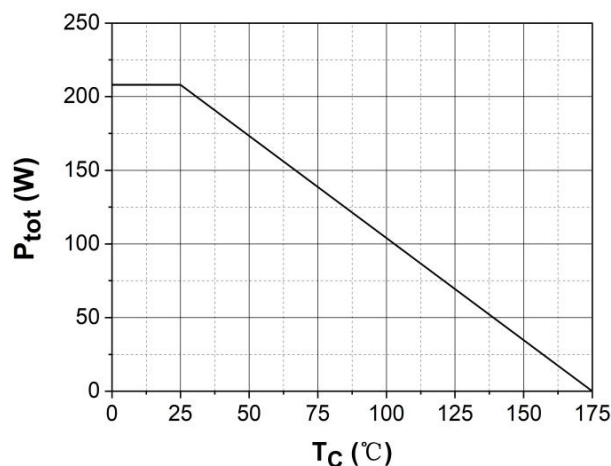


Figure 6. Power Derating

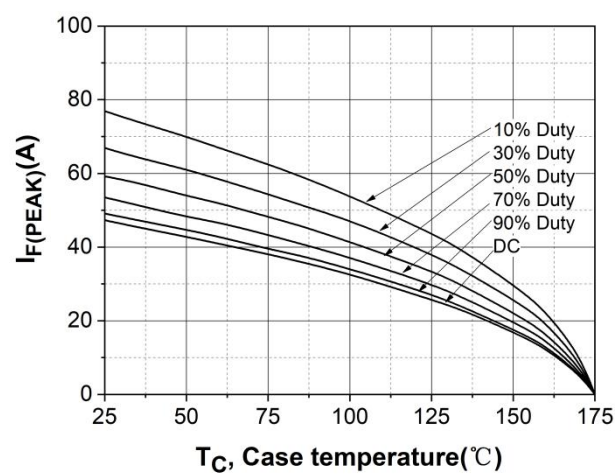


Figure 7. Current Derating

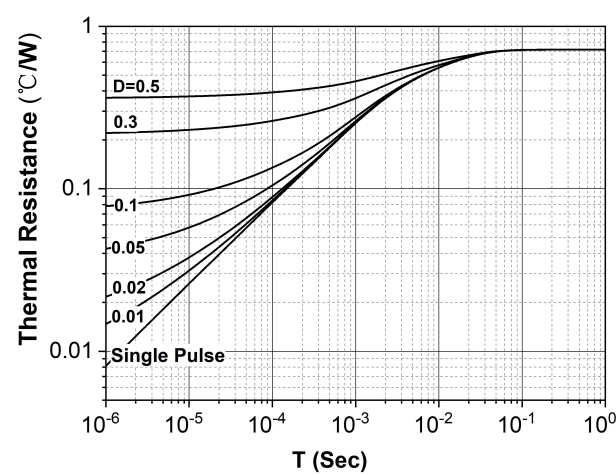


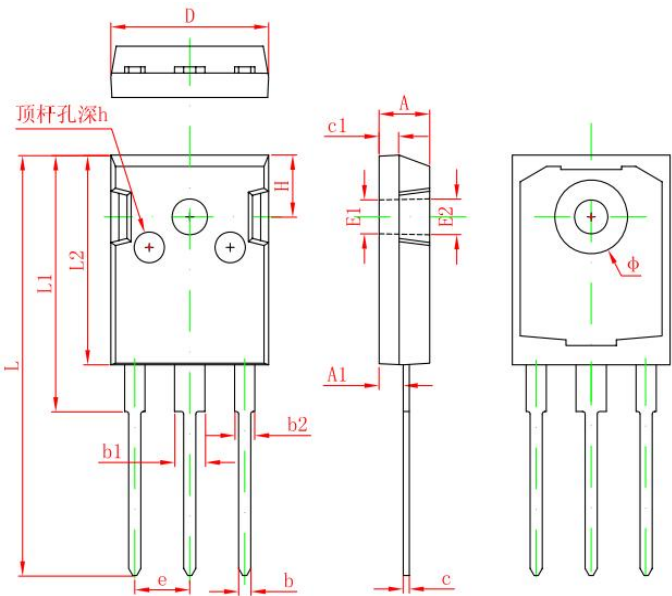
Figure 8. Transient Thermal Impedance

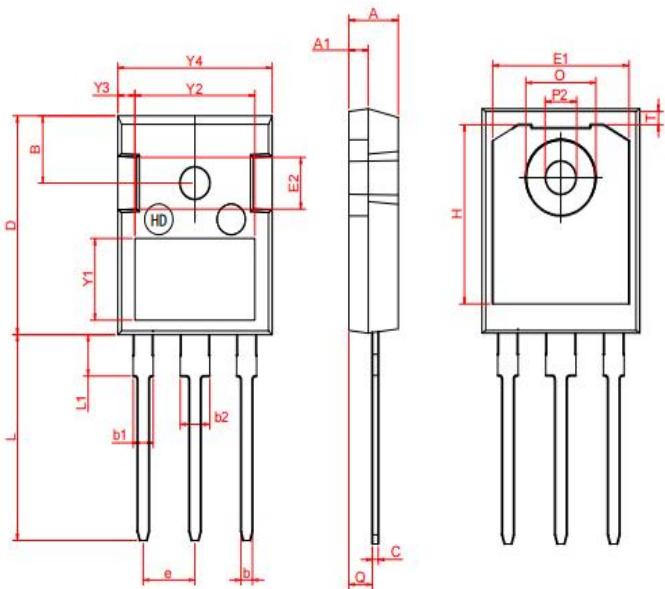
